Minutes of the 144th Academic Council Meeting of Haldia Institute of Technology held on 6th March, 2024 (by off-line mode) at 12.00 noon in the Tamalika Conference Hall of the Institute.

At the beginning of the meeting, the Chairman of the Academic Council heartily welcomed all the members to the 144th meeting of the Academic Council and hoped cooperation & valuable guidance from all distinguished members in transacting the business of the Council.

The Agenda Items were taken up for consideration as follows:

Agenda 144.01: To confirm the minutes of 143th Academic Council meeting held on 3rd August 2023.

The minutes circulated earlier were duly confirmed after discussion.

Agenda 144.02: UG/PG Program Extension of Approval (EoA) from AICTE for AY 2024-25.

After discussion, Academic Council approved Institute's proposal on EoA from AICTE for AY 2024-25 with continuing intakes of AY 2023-24 (14 nos UG programs, 9 nos PG programs including MBA and MCA). In addition, the Institute also applied for extra-intake of 30 (in each UG Programmes - CHE, ME & EE) under "Working Professionals" category from AICTE.

Agenda 144.03: Examination results of UG & PG Odd-Semester AY 2023-24 under Autonomy.

After discussion, the Council noted and approved results of UG & PG Odd Semester AY 2023-24 under Autonomy for publication, as presented by the Controller of Examination [Annexure I]. The Council also requested all departmental HOD/TIC for critical analysis of the result (particularly poor performance in some discrete subjects/papers) and to share those findings with Principal/Registrar for preventive measures. The Council also recommended for arranging extra / bridge-courses for late-admitted students in 1st & 2nd year UG levels alongwith student scoring poor academic performance.

Agenda 144.04: Discussion / Approval of Revised Curricula & Syllabus of UG / PG Programs (approved by respective BOSs) during AY 2023-24.

After long deliberation, the Academic Council accepted recommendations of different BOSs for revised Curricula & Syllabus of UG / PG programs (with 10 - 15% change in course content) as per AICTE / NAAC / NBA guideline. It was also decided that in case of emergency, periodical BOS meeting can be arranged in OFF LINE / ON LINE or hybrid modes.

Agenda 144.05: Status of NAAC and NBA of the Institute.

It was reported that the Institute presently enjoying NAAC Grade-A (with 3.31 CGPA) accreditation valid up to 31 December, 2025. All related documents of NAAC AQAR 2022-23, have already uploaded within stipulated period (31st December, 2023). The same for 2023-24 should be completed before end of December, 2024.

On discussion of NBA activities, it was also reported that presently all eligible 10 nos of UG programs (AEIE, ME, CHE, EE, CE, ECE, CSE, IT, BT and FT) of the Institute are NBA accredited. The NBA visit for re-accreditation of 04 UG programs (CSE, CHE, ME and BT) in Tyre-I has scheduled during 22-24 March, 2024. All concerned (alongwith 1st yr) HODs are requested to take all necessary preparation for the same.

Agenda 144.06: Research Projects / Consultancy Works / MOUs, etc. during AY 2023-24. .

During discussion, it was reported that during AY 2023-24 (till date), some improvements in research / consultancy have been exhibited by various academic departments of the Institute with following details:

- a) The AICTE-IDEA Lab (Project value ~ Rs 1.10 CR) of the Institute has been in full operational state and taking-up various training / skilling activities. During AY 2023-24 (till date), 10 programs (5 - Student Skill Development Program, 3 - Faculty Dev Program, 1 - Professional Skilling Program & 2 - Student Awareness Program) have executed with beneficiary no ~ 210. The Council requested to enhance technical collaboration of AICTE-IDEA Lab with Industry through sponsored project / consultancy for self sustaining purpose.
- b) The Institute has also been recognized as the "HOST Institute" by Ministry of MSME, Govt. of India. Till now for MSME activities, the Institute awarded: (i) Rs 0.90 CR for 6 nos of Incubation Projects in Phase-I, (ii) 0.45 CR for another 3 nos of Incubation Projects in Phase-II, and (iii) 0.60 CR for newly received 4 nos of Incubation Projects (HACKATHON 3.0 for Women) in phase-III. All 13 nos of MSME Incubation Projects (with project value ~ 1.95 CR) are housed in MSME lab. All MSME Project-Incubity members were requested to finish the same within stipulated time.
- c) On-going Research Projects - 7 nos Major Projects from DST, DST-SERB, CSIR, ICMR-DHR, etc. with project value ~ 1.65 CR (in Depts. of AS, ME & EE) and (ii) 7 nos Minor projects from IICHE, Institute, etc. (in CHE, ECE Depts). Besides, 30 nos new research projects have submitted during this period for consideration under various Govt. funding agencies.
- d) During AY 2023-24(till date), 12 nos of consultancy works are in-progress and 10 nos are completed under IIPC. The ongoing consultancy works valued ~ 52.46 L in areas like – (i) design & development planning of Barth no 6 of Haldia Dock Complex (22.0 L by CE Dept.), (ii) Residual life analysis of 5 jetties of Kolkata Port Trust, Haldia (11.0 L by CE Dept.), (iii) Health Assessment of DP Cooling Tower of MCPIL Ltd, Haldia (10.5 L by CE Dept), (iv) Study of Coke Tray Base Plate. (3.0 L by ME Dept.), (v) Preparation of DPR & Setting-up of a Caustic Soda Plant (2.0 L by CHE Dept), (vi) 7 nos of minor consultancy works (< 2 L) like - Industry Staff Skilling / Behavioural Training / Mentoring / Market Survey for Haldia Refinery, Kolkata Port Trust, MCPIL Ltd-Haldia, etc by SASH & MBA Dept.
- e) The Institute already executed MOUs with – (i) 11 nos of Academic Institutes for collaborating research, student exchange, etc.; (ii) 16 nos of Industries for training of student and (iii) 12 nos of Industries for Mandatory Student internship, etc. For better student employability, the Council recommended more Industry interaction / involvement within academic curricula frame work..

Agenda 144.07: PhD works / Research Publications (in - Journal/Book/Book-Chapter/Conference), Seminar / Workshop / FDP / Webinar (organized and attended) / Patent, etc. in the AY 2023-24 (till-date).

It was reported to the house that during AY 2023-24(till date), following are achievements of various academic departments regarding research publications / seminar / workshop / FDP / patents, etc:

- a) Faculty members: received PhD degree – 16 and on-going PhD – 87
Under guidance of our Faculty members: on-going – 43
- b) Paper publication: Journal paper - 103 & Conf. Paper - 129
- c) Book / Book Chapter publication: Books - 5 & Book Chapters - 88
- d) Seminar / Workshop / FDP / Webinar: Organized – 35
- e) Seminar / Workshop / FDP / Webinar: Attended: Seminar – 123, FDP – 666 and Workshop / Webinar - 145
- f) Patent: published / obtained - 38 and filed - 39

During discussion, the Council recommended the share of revenue distribution from Patent (between Faculty and Institute) on the guideline of existing Consultancy norms of the Institute.

Agenda 144.8: Training & Campus Placement Activities – 2024 / 25 batch of student

On discussion of T&P activities alongwith road map for 2024/25 Batch campus-hiring, GM-T&P reported to the Council following activities cum action plan:

- a) For 2024 pass out batch, first slot of campus drive has been shared with IT majors -Accenture and PWC, resulted with the final selection of 50 candidates and 38 candidates respectively. Other major IT companies like - Lab vantage, Tech Mahindra, Cognizant has already initiated their Campus drive process; followed by – Deloitte, TCS etc.
- b) In core sector placement, several reputed companies like - Haldia Petrochemicals, Philips Carbon Black, Resustainability, SHV Energy, Hindustan Unilever, Indorama, Worley India, Amrit Cement, Carbon Resources, etc. have recruited substantial number of candidates.
- c) Till date, 50 companies have visited our Institute for Campus recruitment by Online and Offline modes. The final status of 2024 pass out batch has reached ~ 40% and shall enhance subsequently.
- d) Beside placement, Internship / Training activity for 2024 pass out Batch is at its full swing. Similar activity for 2025 Batch pass out students has also initiated. Practices for Industry visit by Faculty and Students are also in progress routine wise.
- e) As per current requirements of reputed IT-based MNCs, the Council requested concerned HODs / TICs to take appropriate steps like - (i) building student-competencies in latest technologies such as - Sales Force, Cloud Computing, Adaptive AI, etc. and (ii) execution of MOU with MNCs on those thrust areas with maximum 4 course credit.

For improvement of place scenario of 2024 batch, the Council advised T&P Dept for greater interaction with Professional Consulting Firms of IT domain as well as Non-IT domain.


Agenda 144.9: Any other matter with permission of the Chair

With permission of the Chair –

- a) The Secretary of the Institute highlighted the needs of execution of urgent and immediate steps for betterment of academic & financial status of the Institute like - (i) arranging of Tutorial & Special Classes, (ii) Improvement of Mentoring / Teacher-Student interaction in regular & effective way, (iii) Improvement of Student Class attendance, (iv) On-time Semester Fee submission by students, etc. for all departments. All HODs / TICs were requested for immediate implementation of these activities with top priority.

b) HOD-ME highlighted the need of minor changes in their department's Vision statement. After discussion, the Council approved the same.
